### **READING**

#### **Analyze and apply literary elements.**

\_\_\_ Analyze how differences in the point of view of the characters and the audience or reader (e.g., created through the use of dramatic irony) create such effects as suspense or humor. **RL6**

Use precise words and phrases, relevant descriptive details, and sensory language to capture the action and convey experiences and events. #### **Support a textual analysis or argument with evidence.**

\_\_\_ Gather relevant information from multiple print and digital sources, using search terms effectively; assess the credibility and accuracy of each source; and quote or paraphrase the data and conclusions of others while avoiding plagiarism and following the standard format for citation. **W8**

\_\_\_ Draw evidence from literary or informational texts to support analysis, reflection, and research. Use appropriate and varied transitions to create cohesion and clarify the relationships among ideas and concepts. Use precise language and domain-specific vocabulary to inform about or explain the topic. Establish and maintain a formal style. Provide a concluding statement or section that follows from and supports the information or explanation presented. **W2a-f**

### **Analyze words, phrases, and meaning.**

\_\_\_\_\_ Acquire and use accurately grade-appropriate academic and domain-specific words and phrases; gather vocabulary knowledge when considering a word or phrase important to comprehension and expression. **L6**

## **SPEAKING AND LISTENING**

### ***Produce and evaluate research and reading.***

\_\_\_\_\_ Engage effectively in a range of collaborative discussions (one-on-one, in groups, and teacher led) with diverse partners on grade 8 topics, texts, and issues, building on others' ideas and expressing their own clearly. Come to discussions prepared, having read or researched material under study; explicitly draw on that preparation by referring to evidence on the topic, text, or issue to probe and reflect on ideas under discussion. Follow rules for collegial discussions and decision-making, track progress toward specific goals and deadlines, and define individual roles as needed. Pose questions

### **WRITING**

#### **Support an argument with sufficient evidence.**

\_\_\_\_ Write arguments to support claims with clear reasons and relevant evidence. Introduce claim(s), acknowledge and distinguish the claim(s) from alternate or opposing claims, and organize the reasons and evidence logically. Support claim(s) with logical reasoning and relevant evidence, using accurate, credible sources and demonstrating an understanding of the topic or text. Use words, phrases, and clauses to create cohesion and clarify the relationships among claim(s), counterclaims, reasons, and evidence. Establish and maintain a formal style. Provide a concluding statement or section that follows from and supports the argument presented. **W1a-e**

\_\_\_\_ Analyze the purpose of information presented in diverse media and formats (e.g. visually, quantitatively, orally) and evaluate the motives (e.g. social, commercial, political) behind its presentation. **SL2**

#### **Apply conventions of standard English.**

\_\_\_\_ Demonstrate command of the conventions of standard English grammar and usage when writing or speaking. Explain the function of verbals (gerunds, participles, infinitives) in general and their function in particular sentences. Form and use verbs in the active and passive voice. Form and use verbs in the indicative, imperative, interrogative, conditional, and subjunctive mood. Recognize and correct inappropriate shifts in verb voice and mood. **L1a-d**

\_\_\_\_ Demonstrate command of the conventions of standard English capitalization, punctuation, and spelling when writing. Use punctuation (comma, ellipsis, dash) to indicate a pause or break. Use an ellipsis to indicate an omission. Spell correctly. **L2a-c**

\_\_\_\_ Use knowledge of language and its conventions when writing, speaking, reading, or listening. Use verbs in the active and passive voice and in the conditional and subjunctive mood to achieve particular effects (e.g., emphasizing the actor or the action; expressing uncertainty or describing a state contrary to fact). **L3a**

#### **Write for a variety of purposes.**

\_\_\_\_ Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience. **W4**
