Mr. Mason read the Mission Statement.

Public Comment President Mason stated that citizen comments were allowed to address the

Board. Public comment would be limited to 15 minutes with each person

being limited to three minutes.

A concern parent spoke in regards to a January disciplinary issue and asked

the Board and administrators be better tooled to address cyber-bullying

offences.

There were no additional speakers and President Mason declared public

comment closed.

<u>Informational</u> Sarah McIntyre, Summer School Principal gave a brief overview to the

board regarding this year's summer school session. Mrs. McIntyre

highlighted the summer enrollment numbers, class offerings, financial costs, and reviewed parent and staff surveys that were conducted. She noted that she would like to offer more enrichment and academic opportunities such as blended learning, learning through integrated math and science into

literacy to summer school students in future years.

President's Report

President Mason was pleased to announce that the Board of Education had been awarded The School Board Governance Recognition Award. District 123 was one of fourteen districts that had been awarded this designation. The recognition acknowledges those school boards that have engaged in activities and modeled behaviors that lead to excellence in local school governance in support of quality public education.

President Mason also discussed the state budget, addressing the inequities of state funding and to urge the Board to advocate for transparency with our elected officials.

Superintendent's Report

Superintendent Enderle's report included:

- 1st FOIA request
 - The Chicago Lawyer' Committee for Civil Rights requested public records to from August 1, 2013 to show the number of students that have been suspended including times and days, students expelled, referred to an alternate school, including grade, race, gender and disability status of each student. The FOIA was successfully responded to within 10 days.
- 2nd FOIA request
 - A sales administrator for COTG –A Xerox Company requested agreements and leases for the copiers, printers and maintenance contracts for all locations within the district. The FOIA was successfully responded to the following day after it was received.
- Enrollment of 3,044 students, which is only an increase of 8 students from last year.
- The school year began with two successful Teacher Institute primarily dedicated to reinforcing the district's one word theme this year of "Connect".
- Orientation engaged 25 new teachers, using a researched based method called "Teach Like a Champion".
- Parent University partnering program was created by parents for parents. This year input was gathered and 22 new sessions will be offered throughout the year.
- The D123 Extravaganza had a wonderful turn out this year with great opportunities for children. Dr. Enderle thanked the many staff volunteers, Ms. Anderson, Mr. Fetchko, the District's PTAs and PTO and administration for their help in such a successful event.
